



## SUMMARY OF AWARDS & HONORS

### **SELF STORAGE HALL OF FAME**

Established in 2005, the **Self Storage Hall of Fame** exists to honor self storage industry pioneers, innovators, and respected entrepreneurs for their individual accomplishments, organizational achievements, and dedication to the self storage industry. New inductees are honored with a presentation ceremony each year at the Fall SSA Conference & Trade Show.

Candidates for the Hall of Fame become eligible 20 years after they entered the self storage industry. Selection criteria include a distinguished record of accomplishment as a self storage owner, operator, manager, employee or vendor; a proven record of support for and contributions to the self storage industry; significant contributions in other fields of endeavor such as civic contributions, charitable giving, church work or other philanthropic organizations. They are also expected to have demonstrated high moral standards, impeccable integrity, and strong business ethics. Honorees are selected by the SSA Foundation Board of Governors with the input of the SSA Board and membership.

### **MICHAEL T. SCANLON, JR. AWARD FOR OUTSTANDING SERVICE TO THE SELF STORAGE INDUSTRY**

Established in 2015, the **Michael T. Scanlon, Jr. Award** was created in honor of long time SSA President & CEO Mike Scanlon to recognize SSA members who have made extraordinary contributions to the self storage industry.

Potential honorees are proposed by SSA staff with the selections ratified by the SSA Board of Directors. The award is given annually, or less often, when deemed appropriate. Presentations are given at the SSA Spring Conference.

### **BARRY HOEVEN MEMORIAL AWARD**

Established in 2016, the **Barry Hoeven Memorial Award** was created in honor of the late Barry Hoeven to recognize individuals in the self storage industry who, like Barry, have overcome great difficulties in their lives with courage and strength and who have inspired others by their example.

Barry was a remarkable man who showed extraordinary grace and courage in the face of a long fight with cancer. As the founder and president of Westport Properties and U.S. Storage Centers, Barry built one of the largest and most respected self storage companies in the industry. As the Founder of the Kure-It foundation for Cancer Research, Barry lead and inspired efforts which have included raising and funding of nearly \$5.5 million for underfunded cancer research. Honorees are selected by the SSA Foundation Board of Governors, with the input and recommendations of SSA members. The Award may also be presented to honor individuals who have performed heroic acts on behalf of others. The Award is not intended to be awarded annually, rather only when appropriate.

### **SCHOLARSHIPS**

Each year, our association assists and honors the work of individuals in the storage industry who are pursuing their postsecondary education with educational scholarships. **Scholarship Awards** are based on need and scholastic achievement for employees (or their children/grandchildren) of companies that are direct members of the SSA. Eligibility requirements include a demonstrated integrity within school and/or workplace, and a documented pursuit of a meaningful education at an accredited postsecondary education institution. Scholarship recipients are selected by SSA Foundation Board of Governors using applications submitted by the scholarship candidates.
